Terms & Conditions

1. All the participants through their respective guardians agrees to abide by these terms and conditions.
2. LEAD SCHOOL shall not be responsible for non-receipt, delay of any entry. LEAD SCHOOL does not take any responsibility for any errors arising out of incorrect or incomplete entries. The successful entries received by LEAD SCHOOL shall be selected by LEAD SCHOOL as per the details filled in the nomination forms submitted by schools and participants.
3. In case of any dispute or difference in respect of the Entries/Prizes/selection of successful students, the decision of LEAD SCHOOL shall be final and binding on all concerned. The successful students will be intimated by LEAD SCHOOL.
4. The Prizes shall be given to the successful students on production of valid documents for Photo and ID proof.
